PRO TIP: *When deciding what to submit, please remember that your artwork will be reproduced onto t-shirts, billboards, brochures, posters and various other merchandise and marketing items.*

SUBMISSION REQUIREMENTS AND UNDERSTANDINGS:

- All entries will be designed, rendered, and produced at the sole cost of the artist. It is preferred that the artwork width be roughly 1.5 times the height. Inclusion of "Pensacola Seafood Festival" is NOT recommended. A signature in the bottom left or right corner of the artwork is required.
- All entries must be submitted as originals. Artwork cannot be a reproduction, a copy, or bear similar or identical likeness to previous art.
- Artwork may be done using any medium: watercolor, pastels, digital, etc.
- Fiesta will not accept digital copies (*except in the case of digital artwork*). Designs must be delivered or mailed to Fiesta Pensacola, 125 S. Alcaniz Street, Suite 1, Pensacola, FL 32502 during the following business hours: Monday-Thursday 9:00AM-4:00PM (*Closed 12:00PM-1:00PM for lunch*)
- Artist contact information, including name, address, email, and telephone number must be submitted with each entry.
- Artist will agree to irrevocably and forever transfer all right, title and interest in and to the art, its title and related identifying marks to Fiesta. Artwork will be used exclusively for the production of posters, T-shirts, marketing, and other related items for the Pensacola Seafood Festival.
- Submissions should be thematically related to the Pensacola Seafood Festival. Judging will be based on sales and marketing potential. Please be aware that your artwork will be reproduced onto T-shirts and other marketing materials. Please consider the number of colors you are using regarding the ability to reproduce onto merchandise.
- Fiesta reserves the right to reject all work submitted during this competition.
- Fiesta will grant the Artist the right to retain and/or market and sell the **original** production and rendering of the Art (**but NO OTHER duplicates or copies of it**). The artist will be required to sign 150 copies prior to the festival.
- Entries must be appropriate for all viewing ages and not include any of the following: nudes, partial nudes or erotic scenes.
- Fiesta accepts no responsibility for lost or damaged work.
- In addition to artwork featured on all marketing materials, the winning artist will receive \$250 -OR- a complimentary 10x10 booth at the festival. The artist will also receive ten posters. **The 2026 festival is scheduled for Friday-Sunday, September 25-27, 2026.**
- **Poster submission deadline: Monday, July 13, 2026**
